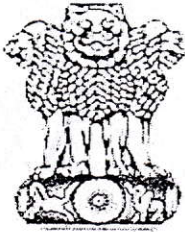

**AMENDMENT TO SER NO. 16.1 PARA 4 OF NOTE OF ARMY SCHEDULE OF
 POWERS 16 UNDER DFPDS-2016 FOR EXERCISING FINANCIAL POWERS TO
 DIRECTOR GENERAL RESETTLEMENT**

Sir,

1. Reference Min of Defence (Fin) Order No. 231(9)/2016/B-II dated 06 Sep 2016.

2. I am directed to refer to provision contained in Ser No. 16.1, Para 4 of Note of Army Schedule of Powers-16 of DFPDS-2016, notified vide Min of Def (Fin) Order referred in Para 1 above and to convey the sanction on behalf of President of India to carry out following amendments of financial powers under Ser No. 16.1, Para 4 of Note of Schedule 16 to Delegation of Financial Powers to Defence Services -2016 :

FOR

In respect of DGR, powers will be exercised by DGR and his officers as per powers given vide MoD letter No. 1918/BUD/DGR/ADM/170/I&C/D(Res) dated 13 Jul 2004 except for the fact that henceforth, all powers of DGR and his officials will be exercised with the concurrence of concerned IFA in IHQ(A). DGR will also get following enhancement in existing powers –(a) Misc & Contingent expenditure – Rs. 5 crore (b) IT – 2 crore (c) Publicity – Rs. 1 crore (d) Seminar/expos – Rs. 2 crore. DGR can delegate powers upto Rs. 1 lakh to various officials of DGR. Cases above DGR powers will be sanctioned by JS(ESW) in MoD with concurrence of MoD (Fin/MO).

Read

In respect of DGR, financial powers without the IFA concurrence and with the IFA concurrence shall be exercised by the authorities on whom these have been conferred under relevant item of expenditure given at Schedule attached to this letter. DGR can delegate powers upto Rs. 1 lakh to officers **not below the ADG rank in DRZs**. Cases above DGR powers will be sanctioned by JS (ESW) in MoD with concurrence of MoD (Fin/Pen).

3. The financial powers delegated to DGR vide MoD order no. 1918/BUD/DGR/Adm/170/I&C/D(Res) dated 13 July 2004 is hereby superseded.

4. This order is issued with the concurrence of MOD (Fin/Pension) vide their U.O. No.32(11)2015/Fin/Pen dated 7.5.2018..
