For:


"Candidate rejected or declared surplus for a commission in the Army or Indian Navy will be entitled to TA when called up for interview for commission in the Air Force."

Read:

"Candidate rejected or declared surplus by Army/Navy/Air Force for a commission will be entitled to TA when called up again for additional interview/medical for commission by any other wing of Tri Services (Army/Navy/Air Force)."
