I am directed to say that National Institute of Mountaineering and Allied Sports(NIMAS) was set up in January, 2013. The Institute is fully funded by Ministry of Defence. Hon'ble Raksha Mantri is the President and Hon'ble Chief Minister of Arunachal Pradesh is the Vice President of the Institute. The Institute conducts various courses in the field of mountaineering.

2. Being a new Institute, construction of road and development of infrastructure alongwith procurement of various kinds of equipment for mountaineering courses is in progress. The construction of main campus of the Institute is also likely to commence soon. Under these circumstances, the presence of Account Assistant is imperative for the purpose of maintenance of accounts. The Institute is authorized an Account Assistant on deputation basis.

3. The post is a Group 'C' post and is required to be filled up on deputation basis for a period of three years, which is extendable up to 5 years. The deputationist will be entitled to his present pay scale plus deputation allowance as applicable under Rules. Other terms and condition will be as per normal terms of deputation.
